NOTICE TO SELLER AND PURCHASER: A.R.S. § 42-5061 provides that the retail seller is liable for the transaction privilege tax. It must be established under A.R.S. § 42-5009 and Arizona Administrative Code R15-5-175 that the sale is exempt. The seller must retain this certificate along with all other documents pertaining to the sale, including all documentation that supports the purchaser's nonresident status. The transaction may be subject to verification. A.R.S. Title 42, Chapter 1 provides substantial penalties for false or inaccurate certificates.

ALL INFORMATION MUST BE CLEARLY PROVIDED AND VERIFIED BY THE SELLER to establish that the motor vehicle was purchased by a nonresident of Arizona and delivered by the seller or the seller's agent, outside the State of Arizona to the purchaser or the purchaser's representative.

I. PURCHASER INFORMATION: A.R.S. § 42-5061 provides an exemption from tax that applies to the sale of a motor vehicle to a nonresident of Arizona for use outside of Arizona, if the seller ships or delivers the motor vehicle outside of the state. A.R.S. § 42-5009 provides substantial penalties for a false or inaccurate certificate provided by the purchaser.

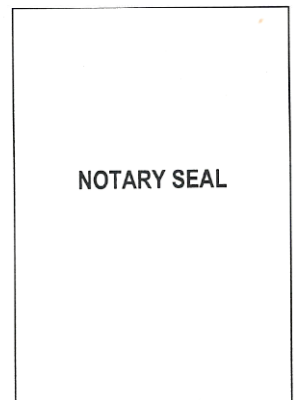
